#### **Obligations of Representative (GSA)**

- 1. Gather all the data required and submit the file of FOC documentation with GACA for obtaining permission with regard to the technical information of the aircraft to be used by the Carrier for its operations.
- 2. Obtain the desired slots for the Carrier from GACA for Hajj/Umrah and scheduled flights.
- 3. Obtain approval/acceptance from GACA of KSA for Aircraft Operator Security Program (AOSP), other manuals and related documentation.
- 4. Negotiate a royalty agreement with Local KSA Airlines as mutually agreed between the Carrier and local KSA Airlines (if required).
- 5. Provide all required administrative services including but not limited to in respect of Saudi Passport Department, Labor office, Government authorities. These services include of residence permits, transfer of Iqama, exit and re-entry visas, visit visas, business visas, driving license, car registration and authentication of official documents from the Chamber of Commerce, GOSI forms and GOSI staff assistance.
- 6. Advise, assist and make sure the Carrier is in compliance with all the local laws and regulations applicable in the Kingdom of Saudi Arabia with regard to its activities.
- 7. Assist the Carrier with all government paperwork, clearances and official offices, with the General Authority of Civil Aviation (GACA), Saudi Telecommunication (STC), Municipalities, Traffic Police and other official offices when needed.
- 8. The GSA, in its capacity according to the agreement will assist and advise the Carrier to ensure their compliance with the laws and regulations of the Kingdom of Saudi Arabia and other related legal matters as may be appropriate.
- 9. Assist with negotiating Payment Terms Only at KSA Airports, Saudi Ground Services (SGS) and Swissport as the Ground Handling agreements will be signed between the airlines and the airport operator.

- 10. Assist in providing Hajj & Umrah Temporary work visas for the mentioned agreed operation as per the Carrier's requirement and on Carrier's cost.
- 11. Assist and obtain Airport Security access passes with the coordination Saudi Ground Services (SGS) and Swissport at KSA airports well in advance before the start of the operations for the staff of the Carrier.
- 12. Assist in negotiating and arranging suitable accommodation including transportation with all required permits for staff of the Carrier.
- 13. Assist in negotiating and concluding the agreement for passenger hotels in case of delay.
- 14. Assist in negotiating and engaging maintenance companies at all KSA Airports for maintenance support for the Carrier's aircrafts as per standby arrangement.
- 15. Assist in getting/obtaining approval to place stand for passenger's guidance at all KSA airports.
- 16. The GSA is capable to provide ground catering services to the passengers as per agreement with the Carrier as agreed menu and price.
- 17. The GSA is capable to provide City Check-In at both Airports JED & MED with the following services if required by the Carrier in case needed:
- a. To handle registered baggage in hotel lobby, weigh, verify and its transportation from hotel to airports.
- b. Provide qualified and proper personnel with uniform and ID card.
- c. Provide serviceable, secure, proper transportation equipment with certification and license in order to support baggage transportation services.
- d. Guarantee its personnel and transportation equipment has the access to hotel in Mecca and Medina to perform baggage transportation to city check-in before ETD flight per group.




- e. Provider's personnel will behave friendly, kind, polite and "prohibited to" perform money collection or receive tip to/from the pilgrims.
- f. Agree to coordinate with relevant institute during performing the service such as: sector to sector, hotel, traffic police, hajj operational carrier (airline) and customs.
- g. Agree to baggage handling workflow and schedule of activity with the agent.
- 18. Assist in providing agreed number of dedicated local staff fluent in Arabic and English who are well versed with the procedures and liaising with authorities at both airports JED & MED to supervise the operations in coordination with the staff of the Carrier as well as assisting temporary deputed staff for the said operation. The lodging and boarding of the local staff is included in the cost of the staff provided locally.
- 19. Assist in providing dedicated Ramp Assistance vehicle for the staff of the carrier during the entire tenure of the entire operations including relevant passes through Saudi Ground Services Company (SGS) and Swissport on Carrier's Expense.
- 20. Follow up with the name and the contact number of the person whom the GSA has nominated for the purpose of this agreement.
- 21. Provide Sales of tickets and marketing for airlines and promote the business of airlines.







Bulk cargo is commodity cargo that is transported unpackaged in large quantities. It refers to material in either liquid or granular, particulate form, as a mass of relatively small solids, such as petroleum/crude oil, grain, coal, or gravel.

All articles, goods, materials, merchandise, or wares carried onboard an aircraft, ship, train, or truck, and for which an air waybill, or bill of lading, or other receipt is issued by the carrier.

#### Cargo, Courier, Express parcels and mail

- ✓ The General Authority of Civil Aviation (GACA) supervised the overhaul Cargo Handling functions at Kingdom's airports through its approved shippers for air cargo, courier, express parcels and mail on behalf of airlines.
- ✓ GACA of Saudi Arabia is applying strict cargo security regime involving the implementation of Regulated Agent concept in accordance with ICAO Annex-17 standard 4-6-4. Under this regime, only GACA's certified regulated agents are authorized to dispatch inbound and outbound air cargo through Saudi Arabian airports.
- ✓ Regulated agent/ GACA's certified shipper's concept is followed at Kingdom International Airports. All cargo and mail accepted for carriage will be screened by the cargo agents. Cargo agents in Saudi Arabia have been authorized by GACA to screen all cargo and seal them before they are brought to the cargo warehouse. There are 10% random checks of cargo by GID at airport location, prior to be loaded in the cargo hold of an aircraft. Perishable cargo is screened by GID at KSA airports.

#### **SCOPE**

Jaz Aviation and its agents' staff who are required to receive specific training or instruction in aviation activities under the terms and requirements of the Kingdom of Saudi Arabia. Training required by Jaz Aviation and its agents' staff working outstations would be governed by local regulations. Where no such regulations are in force, the Jaz Aviation Training department will advise on requirements. The training department also gives an indication of the content and depth of the various training courses prescribed by the General Authority of Civil Aviation of KSA. The aim is to enable responsible managers to know when aviation training is necessary for their own or their agents' staff.

#### **OBJECTIVES**

The objective of aviation training is to ensure that individuals in the aviation industry whose jobs include aviation duties are fully aware of the purpose and practicalities of those activities.

#### **GENERAL**

- ✓ Jaz Aviation Training Program is based on the Saudi Arabian National Civil Aviation Security Training Program (NCASTP) issued by GACA and applicable requirements of other States where operations are conducted.
- ✓ Jaz Aviation training Department shall review and update its Training Program for continuous improvement whenever regulatory or operational changes take place and ensure that such updates are reflect in all related departments training programs.
- ✓ Each Division shall conduct their own training and maintain a record of completion and update their Training Program is coordinated with GACA as applicable.
- ✓ The Training Program has a balanced curriculum of theoretical and practical training that
  ensures:
  - ✓ Jaz Aviation Personnel, and Service providers employee who implement special measures, have the competence to perform their duties;

#### **Auditing in Aviation**

Audits are of increasing importance for aerodromes and authorities when it comes to implementing management systems. Quality management systems (QMS) have proven their value controlling operational processes with focus on quality. As part of the Jaz Aviation continuous improvement cycle, audits are an essential instrument to identify and use potential improvements.

Based on ICAO requirements, the implementation of safety management systems at airports similar principles and instruments are needed to improve the safety of operations. ICAO & GACA's new requirements focusing on aerodromes also includes the use of audits as part of the oversight function by competent authorities. Therefore, aerodrome inspectors have to possess knowledge about auditing techniques.

The Jaz Aviation is always focusing of this training course to its staff on the basic principles of auditing, audit procedures and techniques. Besides the management of audit programs (e.g. as part of a certification process), a close look will be taken on the whole audit process beginning from planning through conduction up to analysis. Alternative procedures will be presented and discussed. The course refers to the basic principles of the guideline for auditing management systems

The course enables the participants to conduct audits in their own organization or to prepare for an upcoming audit (e.g. by an authority or external organization). The audit criteria could be safety, quality or environmental aspects at aerodromes. The participants have the possibility to practice what they have learnt.






